

## Tennessee Bureau of Workers' Compensation (TNBWC) EDI Claims Release 3.1 Announcement STATE OF TENNESSEE—FILING EDI CLAIMS RELEASE 1.0 WILL END ON MONDAY

October 20, 2020

This is a reminder that the date for Tennessee's EDI Claims Release 3.1 Implementation is October 27, 2020. TNBWC encourages Trading Partners and EDI Vendors to review the Implementation Schedule located on the "Implementation Info" page at <a href="https://tnbwcedi.info/impl-info">https://tnbwcedi.info/impl-info</a>. This schedule summarizes the TNBWC transition from Claims Release 1.0 to Claims Release 3.1.

Reminder, any Release 1.0 files sent to TNBWC after 10-26-2020 at 11:59 p.m. CT will not be processed and acknowledged and must be reformatted to Release 3.1 and sent to ISO.

Trading Partners transmitting directly (Direct SFTP) and EDI Vendors are required to complete the Test Plan which can be found at <a href="https://tnbwcedi.info/impl-info">https://tnbwcedi.info/impl-info</a> under the heading "Tennessee Bureau of Workers' Compensation (TNBWC) Claims Release 3.1 Test Plan - Testing Requirements." Testers must request testing feedback from Verisk/ISO by submitting the TNBWC Claims Release 3.1 Test Feedback Request List to <a href="mailto:tnbwcedi@iso.com">tnbwcedi@iso.com</a>. No testing is required for TNBWC Free Web Entry filers.

## **Dry Run Testing**

TNBWC/ISO will perform dry run testing for R3.1 using FROI SROI production data beginning on Tuesday, Oct 27 and ending on Monday, Nov 9. Please continue to submit filings during this time and we will identify any Trading Partner Profile issues. On Nov 9, all acknowledgments for R3.1 filings submitted will be returned.

## **Trading Partner Profile Registration for EDI Claims Release 3.1**

All prospective and current Trading Partners who will be exchanging data with the Bureau via EDI Release 3.1 must register as a new Trading Partner at <a href="https://register.isowc.com/login">https://register.isowc.com/login</a> prior to testing or transmitting R3.1 data. This includes all Release 1 Trading Partners currently registered with TNBWC. Detailed instructions on how to complete the online registration form are available on the Bureau's EDI website at <a href="https://tnbwcedi.info/reg-instructions">https://tnbwcedi.info/reg-instructions</a>.

For Release 3.1 testing and production purposes, it is imperative that Trading Partner and Adjusting Entity identifying information submitted in FROI and SROI filings match the identifying information submitted for each in the R3.1 Trading Partner Profile. Any discrepancies will result in a transaction rejection due to a Sender ID mismatch, Insurer FEIN mismatch, or Claim Administrator FEIN/Postal Code mismatch.
